As you may be aware, the United States Food and Drug Administration (FDA) has been investigating Peanut Corporation of America (PCA), for its role in a recent *Salmonella* outbreak. Recently, PCA vastly expanded its initially limited recall to include all of their peanut and peanut butter products distributed since January 1, 2007. In light of the widening scope of PCA's recall, Nature's Plus is taking part in a nationwide voluntary recall of specific peanut and peanut butter-containing nutritional bars.

As a leader in product quality and safety for over 35 years, Nature's Plus routinely tests all of its finished products to ensure purity and quality. Nature's Plus has tested each lot of its finished products for *Salmonella*, and no *Salmonella* has been detected in any Nature's Plus product. Nevertheless, we are voluntarily participating in this precautionary recall of specific peanut-containing products, as part of our commitment to safety and quality.

Please be aware that there have been no reported incidents of illness or adverse effects in connection with any Nature's Plus products. And, no other Natural Organics products are affected by this recall.


